General Membership Meeting

September 7, 2022

Meeting was called to order by Vice Commander Bob Onorato at 7:30 PM.

All cell phones were silenced and hats removed.

The Pledge of Allegiance was rendered by all persons present.

Vice Commander Onorato invited Past Commander Mark Schilling to present the recommendations from the By-Laws Committee to membership. Mark explained the process to amend the Post By-Laws requiring three readings; and the vote taken after the third reading. Mark presented PowerPoint slides detailing the proposed changes and explained each change. Today's reading is the second time presented to the membership, the first time was at the August 2022 General Membership Meeting.

- Article II, Section 1 Membership Requirements
 - Letter C Spouse Membership
 - #1- would remain the same no change
- ▶ #2 Spouse of a deceased Veteran member may become a lifetime member unless he/she declines the membership. May not hold elected office, has no voting privileges, no annual membership dues. If remarried, the spouse of the deceased Veteran would move to the Associate membership status. May not hold elected office, has no voting privileges, and must pay annual membership dues. The new spouse will not be eligible to assume this membership upon the death of the Veteran spouse.
- ➤ #3 Spouse of a deceased Associate member may assume the membership of the deceased Associate unless he/she declines the membership. May not hold elected office, has no voting privileges, must pay annual membership dues. If remarried, the new spouse will not be eligible to assume this membership upon the death of the Associate spouse.
- ➤ New #4 In the event that a deceased associate member had achieved lifetime membership status prior to their death, the spouse would not be required to pay annual membership dues unless they possess their own membership, however, if the deceased

associate was a voting associate, the voting rights will not carry over and the spouse would become an associate member (if they accept the membership)

New - No member can hold two membership classifications. This would also apply to spouses of deceased Veteran Members who also possess their own membership. The membership committee will address these issues on a case-by-case basis.

 - No Change to opening statement
 - #1 Would remain the same no change
 - #2 Would remain the same no change
- ➤ #3 Pool Associate Proposing to eliminate this classification. All current Pool Associate applicants would be converted to an Associate member.
 - **Letter E Swimming Pool Members:**
 - No change to current language
 - Letter F Associate Membership Limitations:
 - 1. Associate Membership will be limited to 35% of the total Veteran membership

SECTION 3

METHOD OF PROCESSING APPLICATIONS FOR MEMBERSHIP: *Last Amended 12/02/2009.*

- 1. All Veteran and non-veteran application forms are to be properly completed and forwarded to the Executive Board prior to the next Executive Board meeting. Any application that is improperly filled out and submitted to the Executive Board must be returned to the applicant to be completed properly. Sponsors signatures must be legible to continue the processing of the application. Associate applicants will have their place in line held while their application is being corrected.
- a. All Veteran applicants must attach proof of their honorable service in the armed forces of the United States.
- b. A Quorum of the Executive Board must verify all applicants' written proof and the Secretary shall note this fact on the application form. The Executive Board or their designee shall present the applicants in person to the general

membership at the next general membership meeting. This will be considered the first reading. An applicant cannot pay post dues or receive a key card until final approval of the application.

- c. It shall be the duty of the Executive Board to examine all applications. The Membership Committee will investigate by interviewing the applicant's sponsor. The Membership Committee Chairman or Committee Member will assist with the investigation by posting the names of the applicants on a designated bulletin board at the post.
- **d.** The post Commander or his designee will have the names of the applicants placed in the membership section of the post newsletter designated: "Awaiting Final Approval". Any member who has any objections to an applicant must notify the Executive Board in writing or in person prior to the second reading.
- **e.** If no further investigation is warranted by the next general membership meeting, the applicant must then appear in person for the second reading and final approval. Upon final approval of the applicant, the Executive Board will direct the post Treasurer, upon payment of dues to present the applicant with a membership and key card.
- **f.** The application and all records shall be kept in the files of the Membership Committee. If an applicant is unable to attend one or any of the membership meetings as required above, then the applicant and or their sponsor are responsible for informing the Membership Chairman and or the Executive Board.
- **g.** The Executive Board will determine on a case-by-case basis whether to continue to proceed with the processing of the application or place the application on hold until the applicant can appear in person before the general membership.
- **h.** Dues must be paid within 30 days after notification of acceptance as a member; otherwise, acceptance shall be void.

- i. Any member who resides beyond 75 miles of the Wilmington Post #1 will pay dues that are ½ of the dues and any assessment for that current year.
- j. All new members will be subject to a six (6) month probationary period. During this probationary period, a new member may have their membership revoked if in the opinion of the Post Executive Board that such action is necessary and in the best interest of the Post and such revocation is not subject to appeal to the State Board.

Membership was asked if there are any questions; none.

<u>Previous General Membership Meeting Minutes</u> – Vice Commander Onorato asked the Secretary to read the minutes from the previous General Membership Meeting. Motion was made by Gerry Stauffer to approve and wave reading of the minutes as they were previously distributed and posted. Joanne Novak seconded the motion; Vice Commander inquired if there were any objections; none – passed.

Previous E-Board Minutes – Vice Commander Onorato asked the Secretary to read the minutes from the previous E-Board Meetings. Draft minutes from the August 23, 2022 E-Board meeting was read by the Secretary. Vice Commander inquired if there were any questions or corrections; Mark Schilling inquired if the E-Board plans to review the playground proposal with Home, Inc. Vice Commander confirmed –yes and Sam Minutola advised Home, Inc. is aware of the matter. Question was asked regarding upgrade of cameras- Bob Morris noted additional cameras are needed for bar area and kitchen hallway. Question was asked regarding Dick Bostick – Vice Commander Onorato advised he is a long-time Post member who is homebound and is in need of some equipment. No other question. Motion was made by Gerry Stauffer to approve. Mark Schilling seconded the motion, passed by voice vote.

<u>The Treasurers Report</u> – Vice Commander Onorato asked Treasurer Ed Herman to report on the Profit and Loss Statement for July 2022. Ed reported net income for January through July was \$20,508. Vice Commander inquired if there are any questions/ comments from membership; none. Motion was made by Sam Minutola to approve. Randy Scott seconded the motion, passed by voice vote.
