**Delaware Veterans Post # 1**  
**General Membership Meeting**  
**December 3, 2025**

**The meeting was called to order by Commander Jerry Herman at 19:30 hours. All cell phones were silent, and hats removed.**

**The Pledge of Allegiance to the Flag was rendered by all attendees.**

**The Commander stated that he was moving out of order from the normal meeting agenda and called on Election Chairman Chip Roop.**

**Chip asked for all election ballots to be turned into the committee members that are moving through out the hall. Once all the ballots were collected the Commander asked the committee to retire to count the ballots.**

**At this time the Commander called on Toys for Tots Committee Member Florie Henry. Florie asked the Marine representative to come forward at which time she presented him with a donation from DelVets in the amount of \$12, 800.00. The Sgt. Thanked the Post for their continued generosity and stated that the donation along with all the toys that were collected would benefit many this year.**

**The Commander moved back to the regular meeting agenda.**

**Previous General Membership Meeting Minutes – The Commander asked the Secretary to read the minutes from the previous General Membership Meeting on November 5<sup>th</sup>, 2025.**

**The Commander stated that he would not accept a motion to dispense with the reading of the minutes.**

Our total cost of goods was \$14,581.30 for a gross profit of \$23,737.91. Our total expenses were \$36,039.76. Our net income for the month was \$-12,099.35. Year to date we are at a negative \$20,438.30.
